FOREIGN TRADE AND CUSTOMS REGULATORY.

- Planning of schemes and implementation of strategies for the attention of origin verifications initiated by the authorities according to the treaties and commercial agreements subscribed by Mexico.
- Planning of operational schemes and efficient logistics chain taking advantage of tax incentives and exemptions
- Advising in order to obtain authorizations and licensees of bonded warehouse, strategic bonded warehouse in maritime ports and land facilities, as well as the certification for the companies under the safety and logistics chain.
- Advice and obtain export authorization programs (Maquiladoras), as well as certified company "NEEC" and or CTPAT.
- Procedures for unfair trade practices, dumping, special procedures, product coverage, among others.
- Representation before the governmental authorities to obtain authorizations, licenses, permits, criterion rulings, anticipated rulings, compliance with tariff and non-tariff regulations, including beauty, food, automotive and health industries, as well as the compliance with official Mexican standards, "NOMS".
- Actions before the Tax Administration Service in order to guarantee the tax interest, suspend administrative enforcement proceedings, thawing of bank accounts, offering of guarantees, among others.
